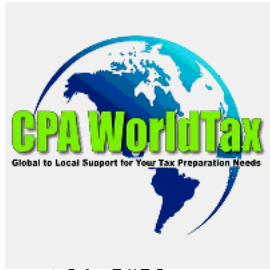

4a (Code:) (Expenses \$ 966,575 including grants of \$) (Revenue \$) The Calapooia Watershed Council (CWC) primary program activities included planting site preparation, maintenance, native plant restoration along local rivers and waterways, wetland prairie restoration, successful completion of a 10 year project at Bowers Rock, Albany, OR, youth watershed education, and community engagement. In FYE 2020 plants were installed and maintained through our restoration program which has received support from Meyer Memorial Trust, the Nature Conservancy & Oregon Watershed Enhancement Board. Staff invested time in regional collaborations to develop our model watershed program's long-term funding, and new partnerships to increase diversity, equity and inclusion measures in our work. We also conducted seasonal monitoring surveys and began work on environmental DNA stream sampling. We continue to work closely with the Oregon Parks & Rec Dept, US Forest Service as well as regional schools through our award winning youth education programs.
